- Comments on the Law 271 approved by assuming responsibility by the Government (while the Parliament's mandate to adopt laws has expired) related to the declared “unprecedented” increases in the salaries of public servants. The legal initiative came from the Democrat party at the height of the electoral campaign without being put into public discussion, requiring considerable spending of public funds, but not even being agreed with the Minister of Finance.

- Comments on the pre-electoral initiative of the Democrat Party on raising the wages of postmen
The situation in the state postal service is really a precarious one and TI-Moldova does not exclude that the real intention is to bankrupt artificially this domain to further pass it to a related private company in off-shore. Several articles in mass-media showed a massive use of postal collaborators in the free dissemination of electoral materials of the Democrat party in the electoral campaign. TI-Moldova sees this legal initiative as an attempt to cover its' electoral campaign from public money which is an infringement of the legal framework that regulates the activity of political parties and funding electoral campaigns.

- The electoral initiative of Democratic Party to provide lump sum of 600 MDL support to the pensionaries, whose pension is below 2000 MDL (the Law 313 from 30.11.2018)1.

The initiative came with a Christmas postcard sent via the state postal service and signed by the oligarch V.Plahotniuc. The oligarch does not hold any public position and packs this initiative as a private one, even though the spending is made from public money. The law has been approved by the Government by assuming the responsibility in a lacking transparency procedure. Moreover, a month later the Government increased considerably the number of beneficiaries of this lump sum support.

- The Government Decision nr.1262², by which it amended two previous decisions on public-private partnerships (PPPs) related to the provision of dialysis and oncological radiotherapy services³:

Within this initiative the Government signed an exclusive contract for dialysis services with a company registered in off-shore extending the duration for 25 years. By this a monopoly is created that having no competitors, will not have an interest in improving the quality of service, even if over the next 25 years, medical technologies will progress much, possibly and will be subtracted with other complete compartments, so patients have no hope of advancing treatment. The total number of patients that receives dialysis treatment in Moldova remains relatively stable; the quality of these services also does not changes, but the allocation from public funds increased in last 4 years four times amounting about MDL 160 Million.

- Position vis-à-vis the Parliament decision to appoint simultaneously 4 out of 5 Directors of the National Agency for Energy Regulation (ANRE) namely Octavian Calmîc, Eugen Carpov, Ștefan Creangă și Veaceslav Untilă, the fifth position remaining open.

- Both the resignations of the former directors of ANRE, as well as the selection and appointment of four new directors, were not transparent, with many suspicions of concerted actions and deviations from the national legislation and from the international commitments assumed.
- The Parliament's decisions regarding the appointment of ANRE directors risk annihilating the European Union Directive 2009/72 / EC which clearly establishes the necessary mechanism for ensuring the functionality and independence of the regulator in the energy field, a provision transposed in the national legislation by the Law 174/2017 on energy.
- The terms of office of the four new directors will expire over 6 years in the same period of time, which could cause the loss of institutional memory and create problems in ensuring the continuity of ANRE management.
- There are major risks of sanctioning the national authorities for non-observance of the commitments to provide independent institutions for energy supervision.

– Providing recommendations to mitigate the risks implied by the “Law on Billion”

In September 2016, the Filip Government assumed responsibility for the Law on the issuance of state bonds for the execution by the Ministry of Finance of payment obligations derived from the state guarantees no. 807 of 17.11.2014 and no. 101 of 01.04.2015 ("Law of the billion"). Converting the guarantees issued secretly by the Leancă (in 2014) 2 and Gaburici (in 2015) 3 governments in internal state debt - 13.3 billion lei in the basic amount and 11.2 billion lei in the form of interest calculated until 2041 led to: social inequity - transposing the burden on tax payers who are not to blame for the billion fraud; impunity of the persons involved in the theft of the billion and of the competent authorities that did not prevent it; annual distraction of considerable financial means.

To solve the problems created by the “Law of the Billion”, TI-Moldova suggests: Immediate cessation of payment from the state budget interest on converting collateral into internal state debt - recommended option to be applied unconditionally; Suspension of the application of the "Law of the Billion" until exhausting all investigative efforts; and recovery of means; Declaring the illegal character of several decisions that facilitated the bank fraud.
